

## Sand or Turf Line Marking Paint Reimbursement Form

The City of Belmont SB2-Donations Financial Assistance Policy allows for a partial reimbursement to local not for profit groups, schools, sporting and recreational clubs on an ongoing basis throughout the calendar year for the following circumstances:

- Provision of sand for recreational purposes - to subsidise schools, playgroups and other non-government organisations to the **maximum amount of \$300 per application per annum.**
- To subsidise specific turf line marking paint, to the **maximum of \$350 per application per approved sporting season.**

### Applicants must meet the following criteria:

- Donations will only be considered on receipt of a formal written application being made on the City's *Sand or Turf Line Marking Paint Reimbursement* form. The form is to be completed in full and submitted with supporting documentation.
- The transaction must have occurred in the current financial year.
- Proof of expenditure (receipts) must be attached.
- Applicants must be located in the City of Belmont.
- Applications will not be considered where costs are fully reimbursed by another body.
