- A large proportion of the laws contained within this document are already in place within existing local laws. It is anticipated having the City's local laws consolidated within the one document, will enable better management of complaints and enforcing infringements.
- The City will be better able to address the ongoing issue of abandoned shopping trolleys by introducing new measures. These include introducing a new system for dealing with abandoned shopping trolleys, including stricter timeframes for removing trolleys in certain zoned areas.
- If the notice of the purpose and effect is approved at next week's Ordinary Council Meeting (OCM), the draft will have a six week public consultation period where the public can make submissions on the proposed local law.
- Once the notice of the purpose and effect of the proposed law is approved, any significant changes made to the draft would require re-advertising. This includes any subsequent increases to the prescribed penalties, many of which have not seen an increase in recent years.
