## 5 Public question time

### 5.1 Responses to questions taken on notice

#### 5.1.1 Mrs G Godfrey, Redcliffe

The following question was taken on notice at the 26 July 2022 Ordinary Council Meeting. Mrs Godfrey was provided with a response on 12 August 2022. The response from the City is recorded accordingly:

1. When can we expect a sign to go up and some landscaping to occur at the roundabout on the corner of Boulder Avenue and Second Street, Redcliffe?

#### Response

Low growing plants/ground cover are scheduled for installation in the roundabout by mid-September 2022

A street name sign for Boulder Avenue is scheduled for installation within the roundabout by 22 August 2022.

### 5.1.2 Mr B Childs, Kewdale

The following question was taken on notice at the 26 July 2022 meeting Ordinary Council Meeting. Mr Childs was provided with a response on 12 August 2022. The response from the City is recorded accordingly:

2. In relation to negotiations with Synergy to achieve Carbon Neutral Status at the Belmont City Council, can you explain how the Carbon Credit System works in relation to Belmont City Council?

#### Response

The question appears to be a follow up question in relation to previous questions relating to the City's purchase of 100% renewable electricity for its "contestable sites".

"Contestable sites" refers to large energy-using sites with electricity consumption over the regulatory threshold of (currently) 50,000 kWh (units) per annum. Operators of contestable sites are able to choose their supplier of electricity for those sites.

As stated in response to previous questions, as of May 2022, 100% of the electricity that the City buys for its contestable sites (listed below) is generated from 100% renewable sources.

- Operations Centre
- Civic Centre, Library and Community Centre
- Gerry Archer Athletic Track
- Ascot Freshwater Lake (circulation pump and aerator)
- Youth and Family Services Centre
- Centenary Park
- Ascot Waters Compensating Basin (irrigation pump for the whole of Ascot Waters and aerator)

This arrangement to buy renewable electricity from Synergy for contestable sites was negotiated by WALGA on behalf of the City of Belmont and other WA local governments.

## 5.1.3 Ms L Hollands on behalf of Belmont Resident and Ratepayer Action Group (BRRAG)

The following questions were taken on notice at the 26 July 2022 Ordinary Council Meeting. Ms Hollands on behalf of Belmont Resident and Ratepayer Action Group was provided with a response on 12 August 2022. The response from the City is recorded accordingly:

1. How is it possible with an additional 4,245 dwellings and an increase in population of 7,586 in the last 10 years that the City believes it is reasonable that the five Rangers the City had in 2011 is still adequate today?

#### Response

The City has been undertaking a review of Ranger and Community Watch services which has, for a number of reasons, taken an extended period of time. It is however essential that the final outcome provides the best service provision at the right cost to the community. Once that review is completed it will be clear whether additional resources are justified.

2. In June there were 41 parking complaints, 12 shopping trolley complaints, 37 wandering dog reports and 41 litter complaints. How many fines were issued and how much revenue was received?

#### Response

In June 2022 you were provided with specific Ranger related statistics as listed in your question.

However overall, City Rangers dealt with 111 vehicle related matters (including abandoned vehicles), 70 dog related matters (including attacks and barking complaints), 12 shopping trolley complaints and 49 litter related complaints. The City issued 21 parking related infringements (\$2,480) and 12 dog related infringements (\$2,400).

3. The City of Belmont has previously paid for the gym equipment for Belmont Oasis costing around \$100,000. How much did the latest round of equipment cost the ratepayer?

#### Response

The previous cardio equipment lease at Belmont Oasis expired and therefore the City was required to seek replacement equipment and an associated lease arrangement. The renewed cardio equipment (installed in May 2022) has been acquired through a three-year lease arrangement at an annual cost of \$70,878.28 (ex GST).

4. On what basis is the City of Belmont spending ratepayer money for chattels such as equipment as opposed to maintaining their building. If this is part of a commercial arrangement, why are such deals being contracted and how does it benefit the residents of Belmont?

#### Response

In reference to the statement made by Ms Hollands regarding the City doing "deals", the City refutes any suggestion that the service was procured in an inappropriate manner, and notes the contractor was selected through a formal tender process. The management operator of Belmont Oasis (BlueFit Pty Ltd) manages the operation of Belmont Oasis on behalf of the City. Under the terms of the contract the City provides the facility, plant, and some equipment to enable the management operator to perform the requirements of the contract, this includes the provision of gym equipment. The operator manages the overall operation of the facility and associated services and programs, which includes the provision of information technology, office/administration, pool testing, sports, childcare and kitchen/catering services. The City regularly undertakes service reviews to ascertain the most suitable mode of delivery for service provision and in relation to the management of an aquatic facility, it has been determined that the most beneficial approach is to engage the services of an experienced aquatic facility operator.

#### 5.1.4 Ms L Hollands, Redcliffe

The following questions were taken on notice at the 26 July 2022 Ordinary Council Meeting. Ms Hollands was provided with a response on 12 August 2022. The response from the City is recorded accordingly:

4. Can you check on point 12.4.1 because it does say in the 2020 Lease that it is the responsibility of the Lessor?

#### Response

The answer provided at the 26 July 2022 Ordinary Council Meeting contained some inaccuracies due to facts not known by staff in attendance.

As previously responded to, the Belmont Sport and Recreation Club (BSRC) are responsible for maintaining the surrounds at the premises. There was a drafting error in the 2020 lease where responsibility for the gardens changed from the lessee to the lessor. We brought this to the attention of the BSRC president at the time who agreed that the BSRC would continue to maintain the gardens as it has always done. It was also agreed, to save on legal costs to both parties, that we would address this in the lease at a later date. It was deferred until such time as we had an agreement in place regarding the bowling greens.

5. What is being done to fix the gardens?

#### Response

The City has written to the BSRC to remind them of their obligations.

7. In the report regarding the BSRC and the Belmont City Bowling Club (BCBC) in the April 2022 Ordinary Council Meeting Agenda, page 44 option 21(sic) states the proposal for a standalone facility is contrary to the approach of the City and other Local Governments in recent years which is to move away from standalone facilities towards on-located facilities. The City have recently budgeted \$100,000 for a feasibility study on the land where the BSRC is located. Is the plan for the City of Belmont to co-locate other facilities in the area and, if so, why would these be considered when the BSRC and the BCBC matter has been a disaster?

#### Response

Considering a best practice approach to asset management, it is a prudent approach to have sporting clubs co-locate in one facility, as opposed to having multiple facilities servicing groups of varying sizes and frequency of use, especially where there are dwindling numbers at the participant clubs. Currently there are several sporting clubs in the City that successfully and collaboratively share facilities.

8. Since flights have started coming in and out of Perth again. Traffic on Epsom Avenue, Durban Street and Stanton Road has significantly increased. When was the last traffic study done and when is the next one due to be done since the changes in circumstances?

#### Response

The last traffic counts were completed in November 2021 with the next count planned for November 2022.

#### 5.1.5 Ms S Carter, Ascot

The following questions were taken on notice at the 26 July 2022 Ordinary Council Meeting. Ms Carter was provided with a response on 11 August 2022. The response from the City is recorded accordingly:

1. Could the City provide me with the number of dog attack reports, the warnings or cautions issued, number of prosecutions whether successful or unsuccessful and if there were malicious complaints lodged about dog attacks in the 2021-2022 financial year?

#### Response

During the Financial Year 2021-2022 the City dealt with 64 reported dog attacks. Of these 27 resulted in the issuing of a caution (or warning), 25 resulted in the issuing of an infringement or infringements and 11 had no further action taken. One prosecution (pending) was instigated. There were no "malicious complaints" lodged.

3. After I was attacked by a dog, the owner of the dog was able to be located very quickly from a photo I supplied. Can the City of Belmont further investigate my dog attack report as I believe the owner is known and the dog may have attacked before?

#### Response

A City Ranger undertook investigations into the incident including the follow up of home CCTV footage, a review of City dog registration records for the area and a Facebook search of Labrador breeds in the area.

The Ranger provided you with two photographs of dogs but you could not identify the actual dog involved. A City Ranger later visited a property where it was suspected the dog lived and subsequently confirmed the dog owner and dog walker's details.

In this case the dog walker provided a version of events where it is claimed you have encroached on her personal space when approaching her and the leashed dog "relatively fast" with an outstretched clipboard. In her opinion your approach has

caused the dog to jump up at you to protect her. This has resulted in your sleeve being torn however no evidence of any physical injuries were provided.

In terms of the Dog Act 1976 there is a defence where a dog can act in "good faith" and in the "reasonable defence" of any person, in this case, the dog walker (Clause 33D, Section 2B(a)). While your version of events differs from that of the dog walker, as there were no other independent witnesses to the incident, this defence is plausible and cannot be disproved by the City.

The circumstances surrounding the attack have been thoroughly investigated. The City's Coordinator Community Safety wrote to you on 22 July 2022, as did I on 1 August 2022, confirming that the investigation had been completed and that the City would be taking no further action in the matter.

4. Could the City please explain what obligations and/or contracts it has with regards to the Ascot Waters Marina Office, for example does the City pay the wages and the lease and whether they pay any other expenses?

#### Response

The City has a lease agreement with Ascot Field Nominees for the Ascot Waters Marina which does not include payment of any expenses by the City.

### 5.2 Questions from members of the public

7.05pm The Presiding Member drew the public gallery's attention to the rules of Public Question Time as written in the Public Question Time Form.

In accordance with rule (I), the Mayor advised that he had registered six members of the public who had given prior notice to ask questions.

The Presiding Member invited members of the public who had yet to register their interest to ask a question to do so. No further registrations were forthcoming.

## 5.2.1 Ms L Hollands on behalf of Belmont Resident and Ratepayer Action Group (BRRAG)

1. The media has stated recently that Belvidere Street along with other streets in other Local Governments are going to be closed off to traffic and made a cafe type area. Has the City of Belmont entered into any discussions with any other parties for this to be discussed in the Media?

#### Response

The Chief Executive Officer stated that the City has not. The City is preparing an Activity Centres Planning Strategy to guide the future development of commercial precincts such as Belvidere Street. As part of this process the City is reviewing the existing design and functionality of these precincts with a key focus on transport, access and activity. More specifically, the strategy will investigate how pedestrian and cyclist movements can be better balanced with motor vehicle access as well as opportunities for public realm improvements and increase of action between buildings and the street. The investigation of the public realm improvements within Belvidere Street neighborhood centre will be undertaken as part of the Belvidere Street Activity Centre Revitalisation Project which will commence the design phase in late 2022.

2. Is there any talk of it being completely closed to vehicles and if so, the impact that may have on residents around the area, with parking outside their houses and traffic coming along the other streets such as Durban Street which already has the rat run from the airport?

#### Response

The Chief Executive Officer stated that he does not believe that to be the case. The design phase will commence late 2022.

3. Will there be public consultation on all of that?

#### Response

The Mayor stated of course.

4. Does the City of Belmont own any land in any commercial or industrial area within Belmont and if so, can I please be provided with a list of properties?

#### Response

The Chief Executive Officer stated that the question would be taken on notice.

5. The City of Belmont introduced the 40km/h speed limit near the Council on Wright Street, what was the process for getting that speed limit, how long did it take and why can't the same process be used for Stanton Road to reduce the speed limit to 40km/h given there are two primary schools on that road?

#### Response

The Mayor stated that the question would be taken on notice.

#### 5.2.2 Ms L Hollands, Redcliffe

1. It has now been three months since the Councillors voted to support the City of Belmont taking over the bowling greens. We were told it would take around three months so that electrical, water and the contract could be sorted out. Have all these requirements which caused the delay now been done? Please advise what has and has not been done and when it will be completed and the City takes over?

#### Response

The Chief Executive Officer stated that the question would be taken on notice.

2. Under section 5.1C (sic) of the Local Government Act 1995, the role of the CEO is to cause Council decisions to be implemented. Given the CEO is yet to implement the Council decision, the Pennant season is commencing next month and the possibility of Bowls WA not being satisfied with the greens. What would be the best course of action for us to take to get the Council decision implemented and do we have to take it outside the City?

#### Response

The Chief Executive Officer stated that he is well aware of what his obligations are under the Act. The City is currently in the process of implementing that Council resolution. The City are working with the BSRC, the bowling club and the greenkeeper and it is the Chief Executive Officer's understanding that the bowling greens will be in condition for the Pennants season.

3. Will that be under the guidance of the City of Belmont or the BSRC?

#### Response

The Chief Executive Officer stated under the guidance of the City.

4. The contract will then be in the City's hands and the City will be paying for it as per the Council recommendation?

#### Response

The Chief Executive Officer stated that as the CEO it is his role to implement Council decisions and that is exactly what the City will do.

5. Last month after the CEO insisted the BSRC maintains the gardens and lawns at the BSRC. When the contract says it was of the lessor i.e. the ratepayer I asked if it could be checked and I got the following response. "As previously responded to, the Belmont Sport and Recreation Club (BSRC) are responsible for maintaining the surrounds at the premises. There was a drafting error in the 2020 lease where responsibility for the gardens changed from the lessee to the lessor. We brought this to the attention of the BSRC president at the time who agreed that the BSRC would continue to maintain the gardens as it has always done. It was also agreed, to save on legal costs to both parties, that we would address this in the lease at a later date. It was deferred until such

time as we had an agreement in place regarding the bowling greens." Did the CEO see this response prior to it being sent to me, and if so, were you in agreement with this and happy with the response?

#### Response

The Chief Executive Officer stated that he did read the response before it was sent and agreed with it.

6. Who made the drafting error, was it the City of Belmont or the lawyers, and if it was the lawyers why are they not paying for the error?

#### Response

The Chief Executive Officer stated that the question would be taken on notice.

7. How is it possible that a drafting error of this nature could occur when it could well cost the ratepayer hundreds of thousands of dollars over a five-year term of the contact and is it possible that drafting errors have occurred in other contracts that are costing the ratepayer?

#### Response

The Chief Executive Officer advised that he does not believe there have been any other drafting errors and stated the remaining part of the question would be taken on notice.

8. In July last year I stated that the latest contract said it was the City of Belmont i.e. the ratepayer paying for the gardens and asked who issued the instruction to the lawyer to change the lease from the BSRC to the City of Belmont. The response from the August minutes is as follows "the drafting and coordination of the lease document was managed by the Manager City Facilities and Property, as noted in the previous response, the Lessee continues to undertake this maintenance." This was a year ago so did anyone bother to check to see if I was correct at that time and if you realised a year ago why didn't you acknowledge the error like you did when you sent me the response in this month's question taken on notice?

#### Response

The Chief Executive Officer stated that the question would be taken on notice.

9. When did the drafting error first come to the attention of the City of Belmont?

#### Response

The Chief Executive Officer stated that the question would be taken on notice.

10. Last month's response stated that the former president agrees to keep maintaining the gardens and change the contract at a later date due to the keeping of legal costs for both parties down. Given the Council only voted three months ago to take over the greens, how could you have possibly known prior to October last year when the former President of the BSRC was there, that there would have been another contract forthcoming and the Council were going to vote to take over the greens?

#### Response

The Chief Executive Officer stated that the question would be taken on notice.

#### 5.2.3 Ms S Carter, Ascot

1. What checks and balances are there on charitable institutions, in this case Umbrella Care Services, for its proposed development of a five-storey data storage facility on its site on the corner of Abernethy and Barker Street, to qualify on an on-going basis for rates exemptions from the City of Belmont, when they appear not to have charitable activities planned for their land?

#### Response

The Acting Director Corporate and Governance stated that Umbrella Care Services are not the proponents for the data centre. The rates exemption are to do with the land use rather than the land owner. In this case when the data centre is established any rate exemption that Umbrella Care Services are benefiting from at this point would not be carried forward.

2. Charitable exemptions are given for land use of charitable purposes, what are the checks and balances?

The Acting Director Corporate and Governance stated that when a development approval is issued the internal administration process is that the rates department are notified of the change in land use. The building permit application will be later issued to establish that the land use has changed, and these are the checks and balances in place. If rate exemptions were previously granted, they do not continue on if the land use changes.

3. Why does such a large block not attract a larger requirement for landscaping, with a few trees being planned for the front verge only?

#### Response

The Acting Director Corporate and Governance stated that the data centre proposal has yet to be determined. When the assessment is completed it will go before the Metro Inner-South Joint Development Assessment Panel to determine and the landscaping requirements will be established then.

4. The Belmont in Brief within the 2019-2020 and 2020-2021 Annual Report have the same figures for population (42,078) and the number of rates assessments. Is that correct?

#### Response

The Mayor stated the question would be taken on notice. The population is probably to do with the census only being done every five years. The last census was done last year after the Annual Report was completed.

5. The accounts that came to Council this month, there is an account for Cellarbrations for \$1,700, that is alcohol consumption account and I looked back in February there was \$700. A total of \$2,400 in 6 months of Council meetings, I thought that was quite a considerable amount.

#### Response

The Chief Executive Officer stated that there has been a backlog in citizenship ceremonies and the City have seen close to 120 to 150 people over the last three citizenship ceremonies plus their families. There is some food and drinks put on after the ceremony. The amount that has been quoted is related directly to those types of functions and certainly not to do with alcohol consumption in the Councillor's Lounge.

#### 5.2.4 Ms L Taylor on behalf of Belmont Senior Club

1. In November 2020, we moved into the Senior Citizens building and reported that the hot water tap in the kitchen was too high and therefore dangerous. We have reported it several times since then and either have been ignored or told that it meets safety standards. In the last three weeks two accidents have occurred with the hot water and the volunteer has been burnt. I ask that common sense prevail and the tap is lowered to a safer height?

#### Response

The Chief Executive Officer stated that the question would be taken on notice.

## 5.2.5 Mrs G Godfrey on behalf of Belmont Senior Club

1. I bring to your attention the state of the flooring in the Senior Citizens Hall. This has been reported to Council officers on the 27 August 2021, 10 December 2021, 15 February 2022 and 7 June 2022. The current floor is a tripping hazard which is critical for seniors to avoid. It affects both our boot scooting and our Tai Chi classes but mainly the carpet bowls. We are sick of the excuses that have been given to us and request Council to urgently replace the current floor with a proper wooden floor.

#### 5.2.6 Mr L Rosolin, Belmont

1. I live on the corner of Hardey Road, the houses numbered 277, 279 and 281 have been knocked down, the land amalgamated, and a new development started. Who is giving permission for amalgamation, is it the Council or the State Government?

#### Response

The Acting Director Corporate and Governance stated that the process of amalgamation is taken care of by the Western Australian Planning Commission so it is a State Government decision. There should not be too many issues that would impede an amalgamation, there are however more controls over subdivision than amalgamation.

2. So the Council doesn't have any voice to oppose that? Because when I was looking to amalgamate my place, they say in the Local Development Plan etc. amalgamation is not allowed. So, I ask is amalgamation allowed or not?

#### Response

The Acting Director Corporate and Governance stated that there is usually little reason why amalgamation would not be allowed. Subdivision is controlled as it is to do with the number of dwellings where there is normally no reason why amalgamation is not allowed. The Western Australian Planning Commission refers amalgamation or subdivision applications to the City and the City does have the ability to provide input or comment as to whether it complies with the Local Planning Scheme. The Western Australian Planning Commission weighs up a number of other factors to determine, regardless of what Council's recommendation is, as to whether amalgamation or subdivision is to be approved.

3. If I send an email with the address provided, can the Council give me an answer as to whether it can be amalgamated or not? The blocks at the corner of Abernethy and Wright Street are they going to be amalgamated?

#### Response

The Acting Director Corporate and Governance stated that if Mr Rosolin sends the City the information he is seeking, the City will provide a reply.

The Community Service Award was initiated in 1977 to recognise and acknowledge services performed by community members and organisations, with five people receiving the inaugural Award. From 1977 to 2021, there have been 110 awards presented with four recipients receiving the Award twice.

The majority of the Awards have been presented to individuals with only two organisations receiving the Award, those being Nulsen Haven (1982) and Belmont Community Food Centre (2000).

The following Award categories have been defined to include people working in the separate areas of:

- **Aged:** This category applies to an individual/community group who contributes within the aged sector (i.e. pensioner groups, activities and services for seniors).
- Community Service: This category applies to an individual/community group who
  contributes within the community (i.e. emergency service volunteer, support
  personnel, religious organisations, culturally diverse communities, charity groups,
  schools).
- People Who Make a Difference: This category applies to an individual/community
  group who has made an exceptional impact, by going above and beyond their duties,
  and making a significant difference in their local community by assisting another or
  others.
- Sport and Recreation (Including Arts and Culture): This category applies to an individual/community group who contributes to organisations such as sporting and recreational clubs as well as arts and culture clubs and organisations.
- Youth: This category applies to an individual/community group who support organisations such as girl guides, scouts, youth clubs, youth centre(s), schools etc.

The Awards are intended to acknowledge the outstanding service given to the community by individual persons and community groups using the following selection criteria:

- 1. The contribution made should be of benefit to the citizens of the City of Belmont (must have provided services to the residents of the City of Belmont).
- 2. Remuneration of an incidental nature will not exclude a nominee from eligibility.
- 3. Nominations can be made in more than one category for any one nominee. Each nomination has to be specific to the category for which the nomination has been submitted.
- 4. The nomination must be submitted on the provided nomination form.

#### Officer comment

The 2022 Community Service Awards were conducted using the selection criteria as resolved by Council at its 28 July 2015 Ordinary Council Meeting (Item 10.2).

The Selection Panel comprised of the Mayor, Chairperson of the Standing Committee (Community Vision), the Chief Executive Officer, Director Development and Communities and the Manager Economic and Community Development. The panel convened on Friday, 3 June 2022 to review and assess all applications.

The panel's recommendations were considered by the Standing Committee (Community Vision) at its meeting on 1 August 2022, resolving that the recommendations be presented to Council.

#### **Purpose of report**

To endorse the updates and amendments made to the Consolidated Local Law 2020. To consider any submissions and the final adoption of the City of Belmont *Consolidated Local Law Amendment Local Law 2022* (refer to Attachment 12.2.1).

#### Summary and key issues

On 16 June 2021, the City of Belmont received correspondence from the Joint Standing Committee on Delegated Legislation (the Joint Standing Committee) seeking an undertaking from Council to make requisite changes to the Consolidated Local Law 2020. The Council made the undertaking at its Ordinary Council Meeting held on 22 June 2021.

In accordance with the legislative requirements the proposed *Consolidated Local Law Amendment Local Law 2022* was advertised 3 March 2022, calling for public submissions. No public submissions were received. The proposed amendment was also referred to relevant government agencies for comment. The Department of Local Government, Sport and Cultural Industries and the Department of Water and Environmental Regulation provided comments suggesting minor administrative changes to the proposed amendment.

These changes have been incorporated to the draft amendment and it is recommended that Council adopts the amendment.

#### Location

Not applicable.

#### **Consultation**

Public consultation of the drafted changes is a legislative requirement. The proposed amendments were advertised from 3 March 2022 to 20 April 2022. The public notice was published in the local newspaper, on the City's website, and on the City's Public Notice Boards in the Library and Civic Centre. No public submissions were received.

In accordance with Section 3.12 of the *Local Government Act 1995*, Local Government is to provide a copy of the proposed Consolidated Local Law Amendment Local Law to the Minister of Water and Environment Regulation and any other Minister that may be affected. It is required that Local Government obtain the approval from the Department of Water and Environmental Regulation. To address this requirement, a copy of the proposed *Consolidated Local Law Amendment Local Law 2022* was forwarded to the Department of Local Government, Sport and Cultural Industries, Department of Water and Environmental Regulation, and Department of Commerce and Trade.

The Department of Local Government, Sport and Cultural Industries and the Department of Water and Environmental Regulation made suggestions to ensure clear drafting principles are met. These suggestions have been incorporated into the Consolidated Local Law Amendment Local Law 2022.

No response was received from the Department of Commerce and Trade.

#### **Policy implications**

#### **Statutory environment**

The City has amended the Consolidated Local Law in accordance with Section 3.12 of the *Local Government Act 1995*.

In accordance with Regulation 3 of the *Local Government (Functions and General)*Regulations 1996 the process of making a Local Law commences with the requirement that the Presiding Member must give notice of the purpose and effect of a Local Law at a Council meeting, and for the agenda and minutes to reflect the Local Law purpose and effect.

The Local Government is to consider any submissions made and may make the Local Law as proposed or make a Local Law that is not significantly different from what was proposed.

After the making of the Local Law, the Local Government is to publish it in the Government Gazette and provide a copy of the Local Law to the Minister of Water and Environmental Regulation and, if another Minister administers the Act under which the Local Law is proposed to be made, to that other Minister as well.

The City must seek consent from the Chief Executive Officer of the Department of Water and Environmental Regulation for local laws relating to waste in accordance with section 61 of the *Waste Avoidance and Resources Recovery Act 2007*.

After the Local Law has been published in the Government Gazette, the Local Government is to give local public notice of the gazettal.

#### **Background**

In June 2021, the Joint Standing Committee requested that the City provide an undertaking to make amendments to the Consolidated Local Law.

It is noted that while the Joint Standing Committee maintains that local law provisions should adhere to WALGA's model provisions, the City holds concerns that the provision of an application process for advertising signage imposes undue operational burden on the City; this is compounded by the inclusion of election signage. The City has consistently maintained an apolitical position in disallowing election signage on verges and City property. Notwithstanding this, amendments were made to address the Joint Standing Committee's requirements, and the draft was advertised publicly and referred to the relevant government agencies.

On 28 March 2022, the Department of Local Government, Sport and Cultural Industries provided their comments regarding the draft Consolidated Local Law Amendment Local Law 2022.

On 19 July 2022, the Department of Water and Environmental Regulation provided their comments noting that their response was delayed due to COVID-19 pressures.

#### **Officer comment**

The Department of Local Government, Sport and Cultural Industries and the Department of Water and Environmental Regulation suggested the following minor edits in their response:

- Inserting words and changes to various headings and clauses
- Punctuation changes
- correcting typographical errors
- Other minor changes to align with legislation.

Attachment 12.2.2 contains a marked-up version of the Consolidated Local Law Amendment Local Law 2022 and Attachment 12.2.3 contains a table detailing the changes.

The Department of Commerce and Trade provided no comment on the proposed Consolidated Local Law Amendment Local Law 2022. As there is no legislative requirement for the Department of Commerce and Trade to provide comment, it is presumed that they have no comment to make, and it is reasonable for the City to proceed with finalising the proposed Consolidated Local Law Amendment Local Law 2022.

Regulation 3 of the *Local Government (Functions and General) Regulations 1996* provides that further to considering submissions from advertising, the Local Government can make the Local Law as proposed, or make a Local Law that is not significantly different from what was proposed. The modifications in light of comments from the Department of Local Government, Sport and Cultural Industries and the Department of Water and Environmental Regulation are administrative in nature and do not change the substance of the advertised amendment. On this basis, it is recommended that the Council adopt the proposed Consolidated Local Law Amendment Local Law 2022 (Attachment 12.2.1).

#### Financial implications

There were costs associated with the advertisement of the public notice and there will be costs associated with the publishing of the Local Law in the Government Gazette. Once gazettal has occurred the City will be required again to provide local public notice. All associated costs are included in the 2022-2023 budget.

- (1) A person must not, without the permission of the local government
  - (a) erect or place an advertising sign; or
  - (b) post any bill or paint, place or affix any advertising sign; or

- (2) If local government approves an application to erect or place an advertising sign on local government property, the approval of the application is subject to the sign
  - (a) being erected at least 50m from any intersection; and
  - (b) being free standing, and not affixed to any existing post, sign, light or power pole or any similar structure; and
  - (c) not create a nuisance or interfere, obstruct, impede vehicular or pedestrian traffic, or any access to a place by any person; and
  - (d) being kept clean and free from unsightly matter including any offensive words or representations; and
  - (e) being securely installed and maintained in a good condition; and
  - (f) not being placed within 100m of any works on footpaths; and
  - (g) has a maximum of 2 facing sides; and
  - (h) being erected so as not to be moveable by wind or natural forces; and
  - (i) not being -
    - (i) illuminated, rotating, flashing; or
    - (ii) incorporate reflective or fluorescent materials; or
    - (iii) displayed on a carriageway, median strip or roundabout; or
    - (iv) attached to any street furniture or natural feature including trees;

or

- (v) attached to or obstruct any other sign; or
- (vi) in any other location where, in the opinion of local government, the sign is likely to obstruct lines of sight along a street or cause danger to any person using the street.

#### 7. Clause 11.8 amended

In clause 11.8 insert the words 'by resolution' after 'may' in the first line.

#### 8. Clause 12.1(2) amended

Insert the word 'and' after each ';' after each term and a full stop after the word 'verge'.

Section 6.4 of the *Local Government Act 1995* in conjunction with Regulations 34 (1) of the *Local Government (Financial Management) Regulations 1996* requires monthly financial reports to be presented to Council.

Regulation 34(1) requires a monthly Statement of Financial Activity reporting on revenue and expenditure.

Regulation 34(5) determines the mechanism required to ascertain the definition of material variances which are required to be reported to Council as a part of the monthly report. It also requires Council to adopt a "percentage or value" for what it will consider to be material variances on an annual basis.

# **Background**

Regulation 34(1) of the *Local Government (Financial Management) Regulations 1996* requires that financial statements are presented monthly to Council. The Statutory Monthly Financial Report is to consist of a Statement of Financial Activity reporting on revenue and expenditure as set out in the Annual Budget. It is required to include:

- Annual budget estimates
- Budget estimates to the end of the reporting month

- Actual amounts to the end of the reporting month
- Material variances between the monthly budgeted and actual amounts
- Net current assets as at the end of the reporting month.

#### Officer comment

Regulation 34(3) of the *Local Government (Financial Management) Regulations 1996* was amended in June 2022, requiring operating revenue or expenses from the 1 July 2022 to be shown according to nature or type instead of by programs. The July 2022 monthly financial activity report has been updated to reflect this change. The change makes the financial activity report more user friendly and has also standardised the financial reporting methodology.

At the June 2022 Ordinary Council Meeting Council has adopted the materiality threshold for the 2022-2023 financial year as 10% of the budgeted closing surplus. The below table provides a summary of significant variations based on this materiality threshold. The detail financial activity report is included at Attachment 12.4.1.
