- There would be no significant impact on the visitor land uses with regards to tourism accommodation.
- The City will ensure that the outcomes we are seeking by the amendment regarding a maximum of 90 days as the STRA will be on

the State Register and if they exceed the 90 days, then this will be a compliance issue for the City to take action.

- The State will notify the City of the time frame and the City will then go out to check compliance.
- A hotel/motel is not a hosted type of accommodation and these previously used terms will be removed from the LPS and will be incorporated into the newly amended LPS.
- The City has the resources to follow up on compliance with the LPS to ensure STRA requirements will be followed, and City Officers will also guide residents in the application of the new STRA requirements of the LPS.

### **Notes from Forum**

- With regards to advertising in relation to the change of use of the block on 2 Carbine Street, the context of the change in land use of the area is worth considering. This will be changed to mixed-use zone lot, and the adjoining lot will be amalgamated with 2 Carbine St by Perth Racing to allow the possibility of further development of this larger lot.
- As for advertising of the amendment, the scheme amendment will be advertised extensively.
- The advertising will notify people of the amendment which includes 2 Carbine Street.
- Development will be sympathetic to housing and the stables area.
- The Council resolution regarding the gates at Carbine St is relevant to the PSP and further to this resolution, the City is waiting on clarification of traffic uses via a report from DPLH. We are still waiting on this report from DPLH.
- With regards to the traffic report for the Ascot area, traffic issues will be dealt with via the Precinct Structure Plan.
- The applicant proposes the area between Matheson Road and Hardey Road as a discretionary land use (at some time in the future) for development of bulky good showrooms.
- The lot at 2 Carbine St could be recommended to DPLH for rezoning but this would be inconsistent with Council's previous resolution with regards to the PSP zones.
- Excluding 2 Carbine St from the Scheme amendment will be inconsistent with Council's previous resolution for this area to be mixed-use in the PSP.
- With regards to a request for an elected member site visit to understand what is proposed by the amendment, this can be done via a request to the CEO as assisted by the DDC.
- The proposed amendment addresses all the land owned by Perth Racing.

### Amendment No. 24 to Local Planning Scheme No. 15

- Animal establishment means premises used for the breeding, boarding and training of animals.
- 2 Carbine St is owned by Perth Racing.
- Advertising letters will be sent as consistent with the PSP letter process which saw letters sent to Ascot Waters, Stable Area and along Great Eastern Highway.
- An animal/veterinary hospital would not be included in the mixed-use precinct as it is not a suitable land use next to residences.
- The potential height for the R60 area is 3 -storeys as consistent with heights in Ascot Waters.

 The Acting Coordinator Planning Projects undertook to prepare a table, similar to that provided for when the PSP was considered in April, in relation to what is being proposed by Perth Racing.

Council would need to go behind closed doors. No questions were asked on the Confidential Attachments.

### **Notes from Forum**

- With regards to height limitations, an applicant could propose development across an amalgamated site.
- With regards to Redcliffe Station precinct and the State Government announcement regarding DA6, the State's position should not affect the proposal.
- The diagrams of the step-down style of development along Great Eastern Highway show the interim transition density development measures from the corridor strategy, with the diagrams showing the first steps closest to Great Eastern Highway.
- There may be further density reductions away from Great Eastern Highway.
- If the DAP currently uses the step-down provisions envisaged in the Great Eastern Highway corridor strategy, then we need to confirm whether our provisions can be made clearer and are being implemented as per our LPP.
- With regards to Main Roads statement regarding the "ultimate" development of Great Eastern Highway, that means that they will not widen Great Eastern Highway. City officers met with Main Roads who confirmed this term means that Great Eastern Highway is as wide as it can be, given the limited amount of land available for any further widening.
- With regards to cul-de-sacs adjacent to Great Eastern Highway, access and parking typologies are shown on diagram 5 with rear access and parking to limit car access points directly to/from Great Eastern Highway. This will limit direct access to lots from Great Eastern Highway.
- We need to be careful with cul-de-sacs as they can channel traffic to other roads. A traffic study is required to fully model and understand traffic movements.
- The State Government announcement regarding the DA6 improvement scheme will be responded to by the City following City officers' review of the draft improvement scheme.

# Local Planning Policy No. 20 - Great Eastern Highway Urban Corridor

- The City is on track with its infill targets and will continue to discuss these targets and development controls with the State Government.
- Industrial areas serve an important purpose and it is important not to undermine the service function of these areas by rezoning them.

### **Further Information to be Provided**

- The Director Development and Communities undertook to investigate whether provision 5.8 can be made any clearer and the adjusted density codes with distance from the Great Eastern Highway.
- The Director Development and Communities undertook to provide more information about the potential to establish cul-de-sacs along Great Eastern Highway similar to Nannine Place or Tanunda Drive.


