Notes from Forum

- In respect to clause 5.4.1, the City would generally require planting of a replacement tree under the Local Planning Policy (LPP) No. 21 should the tree be removed where it is deemed that a tree should be retained.
- Removing a tree specifically to accommodate solar panels, or because it might obstruct them, is uncommon. City Officers believe that this policy will not hinder the installation of solar panels.
- When the City carries out tree removal, no development approval is needed. Such works are covered by the Public Works exemption under the Planning and Development Act 2005 (WA), so the City is not

required to obtain development approval for tree removal, and the draft policy reflects this. City solicitors also noted that including this information in the policy is important.

- Establishing planting ratios for replacement trees presents both advantages and disadvantages. City officers determined that evaluating replacement tree planting on a case-by-case basis would be more appropriate.
- LPP No. 21 was established following the Zorzi vs Town of Cambridge case, highlighting the need to clarify when approval is required for tree removal. This forms the main purpose of the policy.
- City Officers noted that although the City can seek clarification from the Minister for Planning or the relevant State Government agencies about when planning approval is needed for tree removal, it is very unlikely that the State Government will provide their stance on the interpretation of legislation.
- In relation to the notion of transplanting trees, Officers outlined potential issues with reasonableness. Applicants could propose to transplant mature trees, and this doesn't need to be explicitly stated in the policy. The City would review each application on a case-by-case basis.
- The purpose of this policy is not to compensate for canopy loss, but rather to clarify the exemption criteria applicable when tree removal is necessary.
- The decision maker is responsible for determining what is a 'reasonable expected or appropriate development outcome.' What constitutes reasonable is assessed on a case-by-case basis, taking into account the specific application and the context of the site.
- Setting a minimum standard or provision on what is considered a
 'reasonable expected or appropriate development outcome' under the
 policy is challenging because of many variables like lot size,
 development types, and plant species. It is considered more
 appropriate to assess this on a case-by-case basis, taking into account
 the specific application and the context of the site.
- The policy is designed to ensure trees that are sought to be retained in marginal circumstances have the viability of this assessed by an arborist up front. If a proposal requires retention but the applicant later seeks to remove the tree, the City must review that request. Should a tree be taken out without notifying the City, the Planning and

City of Opportunity

Background



- Planning system has not delved into trees being development or the need to obtain planning approval.
- Zorzi v Town of Cambridge Tree removal can constitute 'development' in certain circumstances.
- There is not a consistent State led approach to the matter.
- To provide guidance, local governments should now prepare local planning policies.

WALGA Policy



- WALGA template Local Planning Policy released in 2024, which sought to classify tree removal as development.
- The WALGA Model Policy is not recommended to be adopted because local planning policies do not make tree removal 'development'.
- The appropriate function of local planning policies is to establish exemptions consistent with Clause 61 of the Deemed Provisions.
- An exemption policy effectively achieves the same end outcome as the WALGA Policy.

Policy Application



- Applies to all zoned and reserved land under LPS 15 except where trees are subject to a Tree Preservation Order.
- It will be used in:
 - Determining what is exempt from the need to obtain development approval.
 - Assessing development applications, subdivision applications and strategic planning proposals.

Policy Objectives



- Draft LPP 21 includes four objectives. The provisions of LPP 21 directly relate to these objectives.
- In summary:
 - Clarify when tree removal is exempt from development approval.
 - Promote tree retention as the starting presumption.
 - Provide guidance for assessing proposals.
 - Ensure trees that contribute to amenity are prioritised for retention.

Policy Definitions



- Three definitions are included within the policy to provide clarity:
 - Certified Arborist Arborist who is certified by a professional organisation.
 - Tree Preservation Order Order made by the City under LPS 15 to protect specific trees.
 - **Tree Removal** –killing, removal, ringbarking, poisoning, topping or lopping.

Exemptions from Development Approval



- Less than 8m in height, average canopy diameter less than 6m and has a trunk circumference of less than 1.5m.
- Listed as a weed or is a palm or pencil pine.
- Removal directed by the State Government or Local Government
- Required by a Bushfire Management Plan.
- Works carried out by the City or Belmont.
- Works exempt under Clause 61(1)(b) of the Regulations that are necessary for:
 - Public safety
 - The safety or security of plant or equipment
 - The maintenance of essential services
 - The protection of the environment

Assessment Criteria



- The assessment criteria aims to balance tree protection with development needs.
- It sets out the circumstances in which tree removal may be supported including:
 - Retention is not practical due to design or layout.
 - Tree poses a structural or safety risk.
 - Replacement planting improves canopy outcomes.
- Tree removal will not be supported for minor or subjective reasons

Application Requirements



- Applicants will need to demonstrate why removal should be considered by providing the following:
 - A site plan
 - Justification against the assessment criteria
 - An arborist report in some circumstances
 - Additional technical information requested by the City.

Conditions



- Conditions may be imposed to achieve policy objectives.
- Example: where a tree is to be retained:
 - Must remain unless otherwise approved
 - If removed, replacement planting is required as directed by the City.

- For transparency and so that it can be demonstrated decisions are evidence based, the submission recommends the supporting technical reports be appended.



Retail/Commercial Development



- A range of non aviation related retail and commercial uses are proposed particularly within Airport West.
- Limited justification is included on how these uses aligns with the airport's designation as a Specialised Centre.
- Limited discussion on longer term implications of non aviation development





Zoning



- Airport West Planned as a diverse commercial hub.
- Airport South Intended for industrial and logistics uses.
- Both are proposed to be zoned 'Commercial' which could lead to incompatible uses within Airport West.
- The submission recommends applying an 'Industrial' zoning to Airport South.

Land Use Permissibility



• Submission recommends land uses be more closely aligned with the *Planning and Development (Local Planning Schemes) Regulations 2015*.

Environment



Submission suggests:

- Adding wetland mapping and details on Perth Racing's remapping process.
- Reinstating the 3:1 tree replacement ratio from the previous master plan.
- Prioritising vegetation retention to avoid ad hoc clearing.
- Exploring alternatives to living streams to improve drainage corridor quality and visual appeal.

- Appending the traffic study.
