Registration and renewal

All dogs aged over three months and all cats aged over six months must be registered.

The registration period runs from 1 November to 31 October each year. A renewal must be made by 21 November of the year of expiry of the registration.

Registrations of dangerous dogs, whether declared or a restricted breed, can only be renewed annually.

Registrations are valid until the expiry date shown on the certificate of registration and the registration tag, unless cancelled pursuant to the *Dog Act 1976* or *Cat Act 2011*.

Failure to register or renew the registration is an offence under the Acts. Fines apply.

Transfer of registrations

Registrations are transferable between Local Government Authorities within Western Australia.

To transfer a current registration to the City of Belmont from another Local Government Authority, documentary proof of the current registration must accompany this application. No registration fee is payable until the renewal of the registration is due.

To transfer the ownership of a cat or dog (other than a dangerous dog), documentary proof from the previous owner to which the cat or dog was registered must accompany this form. No registration fee for a transfer of ownership is payable provided the cat or dog is currently registered.

Change of details

The City of Belmont must be informed in writing within seven (7) days of any change of details that are on this form (i.e. ownership, address, deceased etc). Fines may occur for failing to do so.

Microchipping and sterilisation

All cats over the age of six months must be microchipped and sterilised. All dogs over the age of 3 months must be microchipped.

Documentary proof of microchipping and sterilisation must accompany this form. Animals may be exempt from microchipping and/or sterilisation if, in the opinion of a qualified veterinarian, such procedures will adversely affect

the health and welfare of the animal. In which case, a certificate from the veterinarian will need to accompany this form.

Animal owner responsibilities

Animal owners must ensure their:

- Dog(s) and cat(s) wear a collar displaying the owner's name, address and a current council registration tag;
- Dog is under the control of a competent person on a maximum two metre lead when in a public place;
- Dog is exercised off a leash in designated areas only, with the person in control carrying a leash to ensure the dog can be restrained if required;

Penalties apply for failing to comply with these and other requirements of the *Cat Act 2011* and *Dog Act 1976*.

The City of Belmont also recommends that cat owners keep their cats on their own property and keep the cats inside at night. Document Set ID: 4653988

Registration fees and concessions

Holders of a Pensioner Concession Card or a Commonwealth Seniors Health Card together with a WA Seniors Card are eligible for concession fees.

Assistance, security and working dogs

Assistance dogs, as defined by the *Dog Act 1976*, are not required to pay a registration fee.

Commercial security dogs have special requirements under the *Dog Act 1976*. As such, you are required to advise the City if your dog is to be registered as a commercial security dog.

Dogs that are on active duty for a government entity (agency), dogs that are bona fide droving dogs or other working dogs may be entitled to a concession on their registration or may even be exempt for registration.

Cat and dog breeds

If the cat is a pure breed, please write the breed in the Primary breed field. If the cat is not a pure breed and you do not know the mix, please write *Domestic short haired, Domestic medium haired or Domestic long haired* in the Primary breed field.

If the dog is a pure breed, please write the breed in the Primary breed field. If the dog is not a pure breed and you do not know the mix, please write the main breed in the Primary breed field and *unknown Cross breed* in the Secondary breed field.
