The City of Belmont's Public Art Advisory Panel (the Panel) has been established since 2011. The Panel provides a formal mechanism for Council to consult with key stakeholders, seek specialist advice in the growth and development of public art in the City of Belmont.

In particular, it will provide advice to Council on issues relating to public art and make recommendations on public art commissions (including private developer contributions) in accordance with the current 'Public Art Directions and Masterplan or similar strategy/policy'.

In addition, the City may contract, where required, a Public Art Consultant whose key function is to ensure the Public Art Program results in high quality works of contemporary art in the public domain.

The panel consists of, but is not limited to, the following participants:

- Two nominated Elected Members and a nominated proxy, City of Belmont
- Manager Library, Culture and Place, City of Belmont
- Coordinator Arts & Place, City of Belmont
- Manager Parks, Leisure & Environment, City of Belmont
- Manager Economic & Community Development, City of Belmont
- Arts Officer/s, City of Belmont
- Coordinator Planning Projects
- A maximum of two independent community representatives who works and/or resides in the City of Belmont with experience and knowledge in art in the public realm (voluntary nomination).
