

Asbestos and E-Waste Drop-off Day 9:00am – 1:00pm Sunday 14 September 2025 Operations Centre, 180 Planet Street, Carlisle City of Belmont residents and ratepayers only

Items that will be accepted: Asbestos, whitegoods (e.g. refrigerators, freezers, washing machines, dryers, ovens, dishwashers), cardboard, polystyrene, fluorescent light globes, motor oil*, plate glass, mattresses, bed bases, car batteries, aerosol cans, and e-waste listed below.

Asbestos includes sheets from fences, floors, walls and roofs, old linoleum, brake pads, some insulation, lagging tape, eaves-lining, guttering and pipes.

Asbestos <u>must</u> be wrapped and sealed in heavy duty 'builders' plastic to ensure safe transportation to the Operations Centre, asbestos will not be accepted if wrapped in bin liners. <u>Once wrapped, the asbestos should be</u> <u>placed on a pallet or similar so a forklift can safely lift the material from your</u> <u>vehicle. Alternatively, each sheet can be wrapped individually for easy</u> <u>manual handling.</u>

Each household is limited to the <u>equivalent of six (6) fence sheets only</u>. No additional asbestos containing material greater than the above quantity will be accepted.

Accepted e-waste: Batteries*, cameras*, cardboard, computers*, computer peripherals/accessories, expanded polystyrene (EPS)*, gaming consoles, laptops*, light globes, mobile phones*, monitors, printers, remote controls (remove batteries), server equipment, small household appliances, speaker, tablets*, TVs, VCRs, and DVD players.

- * Residents are required to tape battery terminals or place them in a small zip lock bag.
- * It is important to save and delete any personal data or documents from your devices before dropping them off. The City does not accept any liability for your personal data or documents stored on devices once they are dropped off. Instructions on how to erase phone and hard drive data can be found on the product manufacturer's support page, instructions or website.
- * Tape and stickers must be removed from EPS before being dropped off.
- * Residents are required to pour motor oil into a large oil drum on site; contaminated empty containers are then disposed of on site. Up to 60L per resident will be accepted, in containers no larger than 20L each. Motor oil as waste from commercial operations will not be accepted.

Items that will not be accepted: Asbestos, gas cylinders, tyres, and household hazardous waste such as paint or chemicals.

Enclosed footwear and proof of property ownership or residency within the City of Belmont is required.
