Stage 1: Brearley Avenue closure and associated


pre-works;

STAGE 1 Brearley Avenue Closure (2016/17)



STAGE 1 Fauntleroy / GEH Intersection Upgrade (2016/17)



- Right turn pockets required as primary northern access to airport.
- Intersection to facilitate bus route to airport.
- Stages of detailed planning: **Design**

STAGE 1

Coolgardie / GEH Intersection Upgrade (2016-2017)



- Right turn pockets required to facilitate local traffic movement.
- Considered desirable to upgrade intersection at first stage (Brearley closure).
- Pedestrian/cycle crossing required.
- Stages of detailed planning: Preliminary

STAGE 1 Kanowna/Boulder Extension (2016-2017)



- Boulder Avenue requires new access.
- Kanowna Avenue extension (new road) proposed.
- Use of portion of Brearley Avenue carriageway may be necessary in the short term – though not considered desirable.
- Stages of detailed planning: Preliminary

STAGE 1 Central Avenue South Construction (2016-2017)



- Central Avenue South connection required to maintain bus service.
- Ultimate boulevard construction proposed from Second to Dunreath.
- Southern Main Drain to be realigned underground along Central carriageway.
- Stages of detailed planning: **Design**

STAGE 2

Public Infrastructure Delivery & Planning Implementation (2017 - 2020)

- Period 2017 -2020.
- Rail and station construction period.
- Delivery of public open space in stages.
- Redesign of Southern Main Drain
- Upgrade of road network in stages.

STAGE 2 Station Construction (2017-2020)



- Construction Precinct will be received by PTA contractor
- Construction will include:
 - Station;
 - Surrounding Piazza;
 - Road works;
 - Park and Ride.
- Stages of detailed planning: **Design**

STAGE 2 Public Open Space Construction (2017-2020)



- Public Open Space to be developed to accommodate:
 - Native vegetation (mature trees);
 - Community Facilities;
 - Active and Passive spaces;
 - Drainage.
- May occur in a staged manner
- Stages of detailed planning: Preliminary 18 May 2015

STAGE 2

Southern Main Drain Realignment (2017-2020)



- Southern Main Drain intended to be realigned to:
 - Provide a meandering living stream from Central to POS and out to GEH;
 - Form a compensation basin within the POS.
- Requires substantial design work.
- Stages of detailed planning: Preliminary 18 May 2015

STAGE 2 Delivery of Planning Framework (2017-2020)



- Planning framework proposed to be operational by 2017.
- Anticipated that initial development may occur adjacent to key redevelopment areas – station precinct and public open space.
- Stages of detailed planning: Preliminary

STAGE 3 Additional Roads and Full Development (2020+)



- Road upgrades to manage traffic and improve streetscape
- Public space and community facility development
- Private development
- Stages of detailed planning:Preliminary
