

 the people who look after the local government the Council. The Council makes the rules for the local government.

 the people who work in the local government the City of Belmont Officers. We call them staff too.



2. What the group is for

The Council needs the Group to



help the Council to make important decisions.



 make sure the Council spends its money to help people with a disability in the City of Belmont



 make sure the Council tells other groups about what our community needs



 make sure the Council talks about things with the people. A **forum** is a meeting where people can tell us about things. Like the City of Belmont's Access and Inclusion Plan. We call this the AIP.



3. What the Group will do

The Group will



 make sure the local government helps people with a disability



tell people in the community about what we do



help make plans for the City of Belmont.Like the City's Access and Inclusion Plan.



4. Who will be in the Group

In this section we tell you about the people in the Group. We call them **members**.

There will be 20 members in the Group.

How we will choose members



You can tell the Council if you want to be a member. You can ask for a form. The form is called an **Expression of Interest**.



City of Belmont staff read the expressions of interest. The Chairperson also reads them.



Then they choose which people will be community members.



The Deputy Chairperson is the leader


if the Chairperson is away.



5. Group meetings



Meetings will happen every 2 months.



Meetings take 2 hours.



All members must try to come to meetings. The Group can not make decisions if too many members do not come.



6. What the members will do

The Group has a list of what the members should do. We call these the **Advisory Group Guidelines**. You can ask for the Guidelines.



Sometimes the Group will ask members to be on another group. These are called **Working**Groups. A Working Group will study special things about disability.



The Group must follow Council rules.



The local government can tell the Group to change what they are doing.



7. What the Group must not do

The Group



must not agree to do things with other Groups

 must **not** use the City of Belmont's logo for themselves



 must **not** tell the newspapers or TV things about the Group or the local government.
 This is called a **media release**.

The local government will make all the media releases.



The local government can tell the Group to stop.
