### 3.1 Financial Interests

A declaration under this section requires that the nature of the interest must be disclosed. Consequently, a member who has made a declaration must not preside, participate in, or be present during any discussion or decision-making procedure relating to the matter the subject of the declaration.

Other members may allow participation of the declarant if the member further discloses the extent of the interest and the other members decide that the interest is trivial or insignificant or is common to a significant number of electors or ratepayers.

#### Purpose of report

For Council to consider the allocation of elected members with terms expiring in 2025 across the proposed four ward structure submitted to the Local Government Advisory Board following the ward and representation review.

#### Summary and key issues

The Department of Local Government, Sport and Cultural Industries (the Department) has requested that the City informs the Department of the proposed allocation of sitting members to the new wards following the Ward and Representation Review adopted by Council at its Special Council Meeting held on 8 February 2023. As the Local Government Advisory Board (LGAB) is required to make a recommendation to the Minister that includes the relevant consequential matters such as the allocation of sitting members to new wards, Council is to consider the allocation and a resolved position is to be provided prior to the next meeting of the LGAB for consideration of the City's submission.

## Officer Recommendation

Further to the resolution of Council at the 8 February 2023 Special Council Meeting, Council recommends to the Local Government Advisory Board that an order be made under s.2.18 of the *Local Government Act 1995* to designate the continuing five councillors across the new wards as outlined below, and to be taken as having been elected for those wards as at the 2023 local government election.

### **West Ward:**

### **Central Ward:**

### **East Ward:**

### **South Ward**

- Cr N Carter
- Cr J Davis

## Statutory environment

Section 2.18 of the *Local Government Act 1995* states:

### 2.18. Fixing and changing number of councillors

- (1) When a local government is newly established the Governor, by order made on the recommendation of the Minister, is to —
  - (a) specify the number of offices of councillor on the council of the local government; and
  - (b) if the district is to have a ward system, specify the numbers of offices of councillor for the wards.
- (2) When an order is made under section 2.2 discontinuing a ward system for a district, the number of offices of councillor on the council remains unchanged unless the order specifies otherwise.
- (3) The Governor, on the recommendation of the Minister, may make an order —
  - (a) changing the number of offices of councillor on a council; or
  - (b) specifying or changing the number of offices of councillor for a ward; or
  - (c) as to a combination of those matters.
- (4) The Minister can only make a recommendation under subsection (1) or (3) if the Advisory Board has recommended under Schedule 2.2 that the order in question should be made.

Schedule 2.2 of the *Local Government Act 1995* includes:

### 5. Local government may propose ward changes or make minor proposals

A local government may, whether or not it has received a submission —

- (a) carry out a review of whether or not an order under section 2.2, 2.3(3) or 2.18 should, in the council's opinion, be made; or
- (b) propose\* to the Advisory Board the making of an order under section 2.2(1), 2.3(3) or 2.18(3) if, in the opinion of the council, the proposal is —
  - (i) one of a minor nature; and
  - (ii) not one about which public submissions need be invited;or
- (c) propose\* to the Minister the making of an order changing the name of the district or a ward.

\* Absolute majority required.

## Background

Following the public consultation for the Ward and Representation Review a Special Council Meeting was held on 8 February 2023 and the following was resolved:

“That Council:

1. Receive and acknowledge all submissions made during the Ward and Representation Review consultation period. (Attachment 6.2.1)
2. Recommend that the City of Belmont change to a four ward system and reduce the number of councillors to eight; and
3. Authorises the Chief Executive Officer to prepare a report to be presented to the Local Government Advisory Board in accordance with Schedule 2.2(9) of the Local Government Act 1995 recommending that:
  - a. An order be made under s.2.2(1) to abolish the existing ward boundaries for the City of Belmont in 2023 and divide the district into four wards with boundaries as detailed in the map provided in Attachment 6.2.4; and
  - b. An order be made under s.2.3 to name the four wards as indicated on the map provided in Attachment 6.2.4:
    - West Ward
    - Central Ward
    - East Ward
    - South Ward
  - c. An order be made under s.2.18 to change the number of offices of council from nine to eight for the 2023 local government election.
4. Endorse the transition to a four ward and eight councillor structure through a Voluntary Allocation option for the five Councillors with terms expiring in 2025 to be allocated voluntarily, or through a ballot across the four wards.
5. Direct the Chief Executive Officer to arrange a Councillor Workshop within two weeks from the date the City receives approval from the Minister to determine the allocation of the five Councillors with terms expiring in 2025 across the approved ward structure and formally notify the Minister of the outcome immediately.
6. Request that if the four ward and eight councillor option is not considered acceptable by the Local Government Advisory Board, or is rejected by the Minister, that a two ward and eight councillor structure is proposed as detailed in Option 4a within this report with a voluntary allocation of existing Councillors across the two wards to be implemented.”

The Executive Summary and relevant attachments including a copy of the Council reports and resolution for the proposed structure were provided to the LGAB on Friday, 10 February 2023 prior to the deadline of 14 February 2023.

City officers were contacted by a representative from the Department on Wednesday, 1 March 2023 notifying that the allocation of sitting members across the four ward structure proposed was required to be resolved and provided prior to the submission being put forward for consideration by the LGAB.

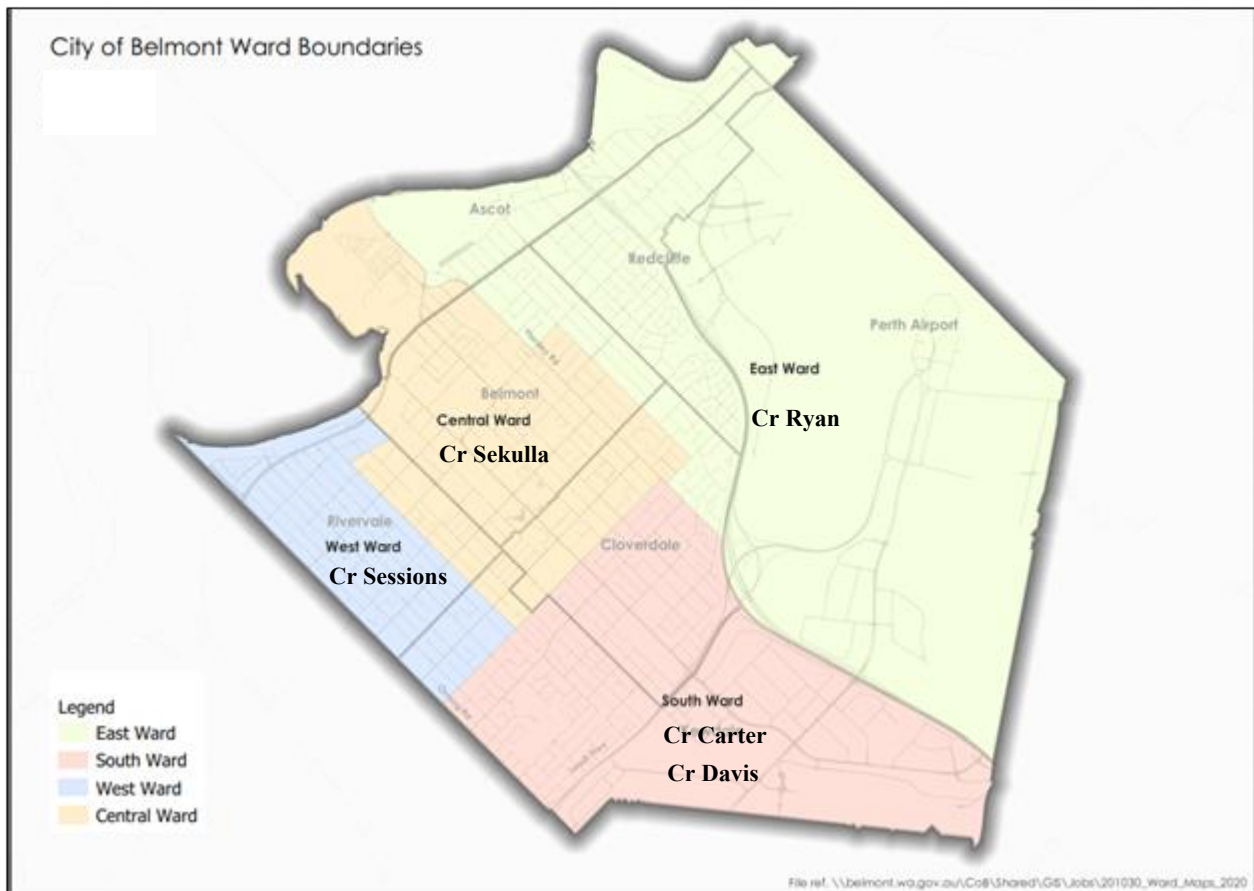
## Report

To transition to the proposed structure allocation of the existing councillors is necessary and the following approach was endorsed by Council as part 4 of the resolution of 8 February 2023.

The five sitting members with terms expiring in 2025 have been consulted regarding their preference and the proposed allocation, which is in accordance with the resolution of 8 February 2023, has been prepared.

The following allocation is proposed:



Any changes to the ward structure and allocation of existing councillors will be in effect for the 2023 local government elections.

### Financial implications

Costs may arise if an extraordinary election is required to fill a vacancy as a result of an existing councillor in the South Ward nominating and being the successful mayoral candidate in 2023 as there will be no councillor election in that ward. The cost associated with an extraordinary election would be approximately \$45,000 to \$60,000.
