Hundreds of tributes have flown in from the Pilbara and wider community to honour the life and legacy of Hedland trailblazer Julie Arif after her sudden passing on January 4.

A passionate local historian, author, volunteer, former council member, visitor centre manager, founding committee member of Port Hedland Lesbians, Allies, Gays Scene (PHLAGS+), Portside Town Team co-founder, Pilbara Development Commission board member and much more, Julie was a cornerstone of her community.

Her dedication to her town was boundless, from organising the Wedge Street Footpath and Cruise Ship Markets to personally making newcomers feel at home with her thoughtful "Welcome to Hedland" packs.

Moving from Geraldton to Hedland at five years old, she lived on old Moore Street alongside six siblings and mum and dad, Jack and Joy (nee O'Brien) Haynes, with all nine family members crammed into a three-bedroom fibro house.

It was in Hedland that she became a mum to Kirsty, Jeremy, Kevin and Cody, all born at Port Hedland Regional Hospital.

"It's fair to say she was a fairly busy mum with myself and my three younger brothers; we were into tee-ball, baseball, football

and cricket, basically every sport," daughter Kirsty Sayers-Hunt said.

"I think that's where everyone got to know her and her sense of community, she always was the mum that would help out.

"Then she started working at Port Hedland Primary School as a teacher's aide and had over 26 years of kindy kids going: 'hello Mrs Hunt', whenever we were down at the shops or in town.

"So wherever we went, Mum knew everyone."

In 2015, Julie also gained two stepchildren, Suzan and Evan, through her loving marriage to Sam Arif.

"I was in awe of her zest for life, love for travel and her unwavering passion for her beloved town of Port Hedland. Those were just a few of the many qualities that made her so special," Sam said.

"She touched everyone around her with her warmth, kindness and infectious spirit. Julie will be deeply missed by all who had the privilege of knowing her, but her memory will live on in the hearts of all who loved her."

Together, Sam and Julie were committee members for Stevens Street retirement village, Dalgety House Museum, Care For Hedland and Hedland Men's Shed. After her children grew up, Julie went on to pursue more community work and became a councillor for the Town of Port Hedland.

"It was pretty evident to anyone that met Mum that she just wasn't going to ever sit on the sidelines; she was always going to be the best advocate you could ever find for Port Hedland," Kirsty said.

"More recently she was one of the founding members of the PHLAGS+ group as well, setting up the Pride events.

"Two of us kids are gay, so I think she was always our fiercest flag-waver and supporter."

Aside from life in Hedland, Julie also had a love for travel, including swimming in the Antarctic Ocean, walking the historic sanctuary of Machu Picchu and watching the Olympics in Atlanta, London, Athens and Sydney.

"I think her sense of adventure came with the first Bali flights out of Hedland in the 1980s and it was pretty unheard of for families at that time to holiday in Bali, but we did it and it was our first overseas trip," Kirsty said.

"So as much as she absolutely adored her country town, she would seek out the best parts of the world to explore as well."

Julie was also a deeply loving grandmother (nanny) to Alora, Maisie, Adam, Saige, Eliza, Ruby, Charlie, Destan and Dillara.

In her later years, she loved nothing more than being in the comfort of her home, with her cat, Lucky, in her favourite chair, enjoying the relaxed Pilbara lifestyle.

"My favourite memory of Mum is probably her lust for life and her sense of fun and adventure," Kirsty said.

"She would just celebrate everything at every occasion, it didn't matter if it was Chinese New Year, Pride or Valentine's Day, she would celebrate everyone all the time."

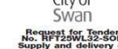
