Competition

1. The City of Belmont is holding a competition to find the most inspiring photos of depicting adventures in Belmont ("Photo(s)") as posted on Instagram ("Competition").
2. Competition will open from 12pm on Friday 11 April 2025 and close on 11:59pm on Sunday 20 July 2025.
3. To enter the Competition, entrants must post a publicly viewable Photo to Instagram with the hashtag #AdventureInBelmont in the caption ("Instagram Post").
4. Photo(s) that do not depict places within the City of Belmont municipal boundary and/or do not include the hashtag #AdventureInBelmont would be disqualified.
5. Entrants may enter multiple competition entries.
6. City of Belmont will select the winning Photo on Wednesday 23 July 2025 and the winning entrant will be contacted via direct message on Instagram.
7. The decision of the City of Belmont in relation to all matters in relation to the Competition, including but not limited to selection of the winning entry is final, and no dispute will be entertained.
8. City of Belmont reserves the right to modify, discontinue, temporarily or permanently, suspend, cancel or alter the Competition at any time without prior notice.

Prize

9. The prize for the winning Photo is a Belmont Forum gift card valued at \$500 ("Prize").
10. The Prize is non-exchangeable, non-transferable and cannot be redeemed for cash.
11. If the winning entrant rejects the Prize or is deemed ineligible, the City of Belmont reserves the right pass the Prize to a runner-up and so on.
12. If the winning entrant does not claim their prize (or arranged with the City of Belmont to claim their prize) within one week of being contacted, the Prize will be offered to a runner-up, who will have a week to claim it, and so on.
